At the date of convening of the AGM, voting rights attached to a total number of 3,818,373 shares of the Company are suspended according to Luxembourg law. The Company's subscribed share capital and number of voting rights suspended may vary at the date of the AGM due to capital increase(s) and share buy-back(s).
